2021 PARTICIPANT INSURANCE REQUIREMENT

We are requiring that each participant at the 2021 National Championship Air Races who brings an aircraft provide evidence of liability coverage on their aircraft subject to the following limits and conditions:

1. **Minimum Liability Limit** - Combined Single Limit \$1,000,000 Bodily Injury and Property Damage.
2. **Identify RARA as an Additional Insured using the following verbiage:** Reno Air Racing Association, Inc., d.b.a. National Championship Air Races, its Directors, Officials, President and CEO, Employees, Volunteers, Agents, Underwriters and Sponsors, Washoe County, City of Reno, Reno Tahoe Airport Authority, University of Nevada, Reno.
3. Include the registered owner of the aircraft.
4. Include the dates September 9 - 22, 2021.

In order to properly review and approve each document, the **certificate of insurance and endorsement** must be received in our office on or before August 1, 2021. It is important that you know that evidence of coverage is a requirement of our air race/show liability underwriters. **Anyone not providing evidence of liability coverage will not be allowed to participate.**

In choosing to participate in the Event, I hereby acknowledge that there are certain inherent risks, including but not limited to, human or mechanical error, Acts of God or other phenomenon that could result in serious injury or death and I freely accept these risks as consideration for being allowed to participate in the Event.

I understand and acknowledge that, with limited exceptions, each pilot is in full and complete control of his or her aircraft and is responsible for all decisions concerning all things and persons in or connected with the aircraft, whether on the ground or in the air, including, but not limited to operating the aircraft, determining whether that aircraft is in condition for safe flight, and assuring that the aircraft has been properly maintained and is otherwise suitable for my participation in the Event. The Event's officials may provide guidance, advice or other information, but I understand, acknowledge, and agree that I act or rely on all such information at my own peril and said officials assume no responsibility for the completeness or accuracy of such information.

I understand and acknowledge that the Technical/Safety Inspection Committees will inspect all aircraft entered in the Event but that such inspection is only for the purpose of determining whether the aircraft complies with the eligibility rules for the applicable race class and other rules of the Event. I understand and acknowledge that such inspections are not conducted by the Association or anyone acting on their behalf and that the approval of the aircraft by the Technical/Safety Inspection Committees does not constitute a representation or warranty of any kind or character whatsoever concerning the mechanical condition of the aircraft, or whether it is airworthy. I hereby acknowledge and agree that it is my sole responsibility as the pilot of the aircraft to ensure that the aircraft is properly maintained, airworthy, and suitable for participation in the Event and that no information provided to me by any of the Released Parties or anyone else shall in any way alter my responsibilities in this regard.

Any commercial use of such photography will be subject to the Association's prior written approval and shall be subject to Association's licensing fees. I hereby irrevocably give the Association and its affiliates, successors, licensees, agents, and assigns ("Authorized Persons") my permission, and grant such Authorized Persons the right, to film, record, and photograph me during my participation in the Event. Further, I hereby irrevocably permit, authorize, and license the Association and the Authorized Persons to use my name, likeness, appearance, voice, and all materials



created by or on behalf of the Association that incorporate any of the foregoing. I acknowledge and agree that the Association (and its successors, assigns, and licensees) is and will be the sole and exclusive owner of all right, title, and interest of every kind in and to all photographs, video and audio recordings, and other depictions made in any format and media with respect to the Event ("Recordings"), including all copyrights and other intellectual property rights therein, in perpetuity throughout the universe for all purposes, including the right to use and/or exploit the Recordings for any purpose, whether commercial or otherwise. I understand and acknowledge that any sale, lease, rental, broadcasting, publishing, televising, or other commercial use/exploitation of any Recordings without the express written consent of a duly authorized representative of the Association shall infringe upon the federally protected rights of the Association, and may subject me to civil liabilities for monetary damages and injunctive relief as provided by law.

I hereby acknowledge that the provisions of this Agreement are severable and in the event any provision, clause, sentence, section, or part thereof is held to be invalid, illegal, unconstitutional, inapplicable, or unenforceable as to any person or circumstances, such invalidity, illegality unconstitutionality, inapplicability or unenforceability shall not affect or impair any of the remaining provisions, sentences, clauses, sections, parts of this Agreement or their application to me or other persons or circumstances. To the extent that any portion of this Agreement is found to be invalid, illegal, unconstitutional, inapplicable, or unenforceable, such words or phrases shall be deemed to be stricken and the remainder of the provisions and remainder of the other portions of this Agreement shall remain in full force and effect.
